Step 4: Get the word out! Pass out flyers, send emails, create an event on Facebook, make posters, or contact local newspapers/TV stations to promote the event. *Your group must bring in a minimum of 50 guests. With effective promotion of the event, this should be very easy!*

Step 5: DQ will donate 20% of net sales from receipts in connection with your Fundraiser Night, within 30 days. ****Sales not including sales tax.**



FUNDRAISING OPPORTUNITY

1. Dairy Queen Grill & Chill in the Rochester, NY area is owned by Operation Brain Freeze, LLC. (OBF).
2. To allow successful communication between DQ and the group, the group will need to designate *only* two representatives that will be authorized to speak with OBF on any matter regarding the fundraiser.
3. The fundraiser night will be scheduled no sooner than three weeks after the Fundraiser Agreement is signed. This time frame allows the group to properly promote the event. We encourage the group to pass out flyers, send out emails, create posters, or contact local newspapers, radio & TV stations to promote the event. *DQ will provide a fundraiser flyer via email upon request.*
4. **The DQ logo can only be used in the flyer provided by DQ to be in compliance with DQ corporate branding and marketing guidelines. Please see one of our managers for the flyer to use for your fundraiser.**
5. The Fundraising Manager will contact the Group Leader one week before the fundraiser to confirm that the event is still on as scheduled. If we are unable to make confirmation, the event will be canceled due to staffing requirements and preparations.
6. The group *must* bring in a minimum of 50 patrons during their fundraiser in order to receive the 20% donation. Effective promotion of the fundraiser event will make this number easy to achieve.
7. **IMPORTANT: Members of your group may not stand outside the store, in front of the entrance, or inside the store to solicit customers to participate in the fundraiser. All flyers/notices of the fundraiser need to be distributed prior to the fundraiser.**
11. OBF will donate 20% of net sales (not including sales tax) from customers that mention your group's fundraiser when they place their order during your event.
12. A duplicate of each receipt in connection with the fundraiser will be collected. The duplicate receipts are then totaled at the end of the night and the total is reported to the Fundraising Manager.
13. The total raised by the fundraiser will only be given to the group's primary contact by the Fundraising Manager. Any request for a total prior to the end of the event will not be honored. This will allow the employees to focus on providing excellent customer service which will contribute to the success of the fundraiser.
14. The Fundraising Manager will contact the group's group leader within 2 days following the event to inform them of the final sales results and the total donation amount. Pickup of the

donation check (within 30 days of the fundraiser night) will also be scheduled.

We are committed to making this a successful event and by following the above procedures and requirements, we are sure your fundraiser will be a big hit!
